### NOTICE OF FILING, PUBLIC HEARING, AND PROCEDURAL CONFERENCE

D.P.U. 17-GREC-01

May 10, 2017

Petition of Fitchburg Gas and Electric Light Company d/b/a Unutil, pursuant to G.L. c. 164, § 145 for review and approval of the reconciliation of its 2016 Gas System Enhancement Plan and for review and approval of its Gas System Enhancement Reconciliation Adjustment Factor.

On April 28, 2017, Fitchburg Gas and Electric Light Company d/b/a Unutil (“Unutil” or “Company”) submitted to the Department of Public Utilities (“Department”) a reconciliation of its 2016 gas system enhancement plan (“GSEP”) to replace aging natural gas pipeline infrastructure. On May 1, 2017, the Company submitted an update to its reconciliation. Based on Unutil’s reconciliation, the Company proposes to collect \$308,598 from ratepayers as under recoveries through the gas system enhancement reconciliation adjustment factor (“GSERAF”) for the period from May 1, 2016, to April 30, 2017. In addition, the Company seeks a waiver of the 1.5 percent cap on annual changes in the revenue requirement eligible for recovery. The Department has docketed this matter as D.P.U. 17-GREC-01.

Unutil states that approval of the GSERAF reconciliation will result in an average monthly bill increase of \$2.64, or 1.24 percent, for the average residential heating customer using 114 therms per month during winter months, and an average monthly bill increase of \$0.55, or 1.09 percent, for the average residential heating customer using 24 therms per month during summer months.

The Attorney General of the Commonwealth of Massachusetts (“Attorney General”) filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E(a). Further, pursuant to G.L. c. 12, § 11E(b), the Attorney General filed a notice of intent to retain experts and consultants to assist her investigation of the Companies’ filings, and has requested Department approval to spend up to \$150,000 in this regard. Pursuant to G.L. c. 12, § 11E(b), the costs incurred by the Attorney General relative to her retention of experts and consultants may be recovered in the Company’s rates. Any person who desires to comment on the Attorney General’s notice of intent to retain experts and consultants in this matter may submit written comments to the Department not later than the close of business (5:00 p.m.) on **May 25, 2017**.

The Department will conduct a public hearing to receive comments on Unitil's petition. The hearing will take place on **June 1, 2016, at 2:00 p.m.**, at the Department's offices, One South Station, 5th Floor, Boston, Massachusetts, 02110. A procedural conference will take place immediately following the public hearing to establish a schedule for the evidentiary phase of this proceeding. Any person who desires to comment may do so at the time and place noted above, or submit written comments to the Department not later than the close of business (5:00 p.m.) on **June 1, 2016**.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business (5:00 p.m.) on **May 25, 2016**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 C.M.R. § 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 C.M.R. § 1.01(4). To be allowed, a petition under 220 C.M.R. § 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed. An original and two (2) copies of all written comments or petitions to intervene must be filed with Mark D. Marini, Secretary, Department of Public Utilities, One South Station, 5th Floor, Boston, Massachusetts, 02110 not later than the close of business (5:00 p.m.) on the dates noted above. One copy of all written comments or petitions to intervene should also be sent to Unitil's attorney, Patrick H. Taylor, Senior Counsel, Unitil Service Corp., 6 Liberty Lane West, Hampton, New Hampshire, 03842-1704.

The electronic filing should also include the name, title, and telephone number of a person to contact in the event of questions about the filing. All documents submitted in electronic format will be posted on the Department's website.
