NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 17-138 September 12, 2017

Petition of Fitchburg Gas and Electric Light Company d/b/a Unitil for review and approval of its basic service costs adder rate adjustment for effect December 1, 2017.

On September 1, 2017, Fitchburg Gas and Electric Light Company d/b/a Unitil ("Company"), filed with the Department of Public Utilities ("Department"), its annual basic service costs adder ("BSCA") rate adjustment and reconciliation filing. The Department docketed this matter as D.P.U. 17-138.

The Company proposes to recover through its BSCA the reconciliation of its electric supply-related costs and revenues from June 2016 through May 2017 and its supply-related forecasted costs from December 2017, through November 2018, which include: (1) cash working capital; (2) bad debt; (3) hardship protected account payments; (4) administration of basic service; (5) conducting the competitive bidding processes; and (6) regulatory compliance.

The Company proposes a BSCA of \$0.00570 per kilowatt-hour ("kWh") to take effect on December 1, 2017 for all customer classes, a decrease of \$0.00062 per kWh from the current rate. As a result of the proposed change to the BSCA, a typical average basic service residential customer using 600 kWh per month would experience a bill decrease of approximately \$0.37, or 0.3 percent per month. The Company states that the impact for the average customer for each rate class on basic service will range from a decrease of 0.2 percent to a decrease of 0.5 percent depending on class and usage. For specific bill impacts, please contact the Company as shown below.
