

2019-2020 Emissions Summary

The following emissions summary compares data from the 2019 and 2020 greenhouse gas emissions inventories. Due to the magnitude of Unitil's Scope 3 emissions from energy delivery to customers (electricity and natural gas), these emissions are represented in Figure 1 with a broken y-axis. All emissions figures are in metric tons of carbon dioxide equivalent (MTCO2e).




Figure 2: 2019-2020 Scope 1 Summary Chart




Figure 1: 2019-2020 Emissions from Fuel Use at Company Buildings




Figure 4: 2019-2020 Emissions from Fugitives




Figure 5: 2019-2020 Emissions from Road Business




Figure 6: 2019-2020 Scope 2 Summary Chart





Figure 7: 2019-2020 Emissions from Electricity Use at Company Buildings






Figure 10: 2019-2020 Emissions from Waste




Figure 11: 2019-2020 Emissions from Water




Figure 12: 2019-2020 Emissions from Delivered Energy




Figure 13: 2019-2020 Emissions from Commuting
