The winter period is defined as the billing months of November through April.

The credit shall be based on full Delivery Service rates plus the Local Distribution Adjustment Clause plus Default Service Charges, if applicable. The credit will be recalculated as required to maintain the ten percent discount from these rates as in effect from time to time.

#### **DEFAULT SERVICE**

Default Service is available to all customers under this Schedule pursuant to Section 15.0 of the Company's Distribution Service Terms and Conditions.

#### TERMS OF PAYMENT

The charges for service under this Schedule are net, billed monthly and payable upon presentation of bill. Interest charges will be added in accordance with the Company's Distribution Service Terms and Conditions.

# TERM OF CONTRACT

The term of contract under this Schedule shall be for an initial period of at least one year, at the expiration of which initial period it shall automatically renew itself for like one year periods thereafter unless terminated by either party giving to the other notice in writing 30 days prior to the expiration of any contract year. The Company may require longer initial and renewal contract terms whenever, in its opinion, the Customer's capacity requirements warrant a longer contract period.
