ROOM AIR PURIFIER BEST PRACTICES

Look for the ENERGY STAR

In addition to reducing greenhouse gas emissions, choosing an ENERGY STAR certified room air purifier over a standard model can save you \$200 in energy costs over the life of the product.

Check your room size

Be sure to consider the square footage of the room where you will place the room air purifier. Larger models use more energy, so choose a model that is sized appropriately to fit your room.

Consider placement

While many room air purifiers are designed to sit on the floor, tabletop models and wall-mounted designs are also available. Regardless of configuration, it is important to read the accompanying product manual for instructions on where to place your room air purifier to achieve optimum performance.
