- Rebate must be postmarked or submitted online no later than **January 31, 2020**.

DEHUMIDIFIER BEST PRACTICES

The average ENERGY STAR certified dehumidifier can save consumers about \$175 over the life of the unit, while avoiding 2,800 lb of greenhouse gas emissions.

ENERGY STAR certified models have more efficient refrigeration coils, compressors and fans than conventional models, which means they use less energy to remove moisture.

An ENERGY STAR certified dehumidifier removes the same amount of moisture as a similar-sized conventional unit, but uses 15 percent less energy.
