Modification of Order No. 26,422 Effective Date and Comment Opportunity Timeline

To the Parties:

On November 6, 2020, the Commission issued Order No. 26,422 in the instant proceeding. To provide an opportunity for interested parties to comment, the Commission elected to issue Order No. 26,422 as an Order *Nisi*. The Commission required Unitil Energy Systems, Inc. (Unitil) to publish a copy of the Order No. 26,422 on its website within one business day, established certain deadlines for interested parties to comment or request a hearing subsequent to that publication, and required Unitil to file an affidavit of publication with the Commission.


On November 16, 2020, Unitil filed an affidavit of publication with the Commission. In the cover letter that accompanied the affidavit, Unitil explained that, due to an internal miscommunication, the order was not published on the Company's website until two business days after the publication date established by the Commission. In light of this error, Unitil requested that the Commission find the Company has substantially complied with the Order *Nisi*, or alternatively, modify the order to move the deadlines therein by two business days.

To preserve a reasonable opportunity for comment, the Commission has determined that modification of Order No. 26,422 would be in the public interest, and establishes a modified timeline for comment and effective date, as detailed below:
