Unitil provides energy for life by safely and reliably delivering natural gas and electricity in New England. We are committed to the communities we serve and to developing people, business practices, and technologies that lead to dependable, more efficient energy. Unitil Corporation is a public utility holding company with operations in Maine, New Hampshire and Massachusetts. Together, Unitil's operating utilities serve approximately 104,300 electric customers and 79,900 natural gas customers. Other subsidiaries include Usource, Unitil's non-regulated business segment. Subsidiary Profiles:

Fitchburg Gas and Electric Light Company, a Massachusetts corporation organized in 1852, became part of the Unitil system in 1992. Today, our Massachusetts electric and gas operations provide distribution service in a 170-square-mile service area in north-central Massachusetts, with a combined estimated population of 92,000. This includes electric distribution service to approximately 29,700 customers and natural gas service to approximately 15,600 customers. Towns serviced include Ashby, Fitchburg, Gardner, Lunenburg, Townsend, and Westminster.

Granite State Gas Transmission, Inc. was incorporated in New Hampshire in 1955 and became part of the Unitil system in 2008. Our interstate gas transmission's principal business is delivering natural gas transportation services to Northern Utilities and providing access to inter-state natural gas pipeline supplies over 87 miles of FERC-regulated pipeline located primarily in Maine and New Hampshire.

Northern Utilities, Inc. was incorporated in New Hampshire in 1979 and became part of the Unitil system in 2008. Northern's predecessor companies date back over 150 years to the Portland Gas Light Company formed in 1849. Our Maine and New Hampshire gas operations serve 64,260 customers in 44 communities in the Seacoast region of New Hampshire and southern Maine. Towns serviced in New Hampshire include Atkinson, Brentwood, Dover, Durham, East Kingston, Exeter, Greenland, Hampton, Hampton Falls, Kensington, Madbury, Newington, North Hampton, Pelham, Plaistow, Portsmouth, Rochester, Rollinsford, Salem, Seabrook, Somersworth and Stratham. In Maine, towns include Auburn, Biddeford, Cape Elizabeth, Cumberland, Eliot, Gorham, Kennebunk, Kittery, Lewiston, Lisbon, Lisbon Falls, New Gloucester, North Berwick, Old Orchard Beach, Poland, Portland, Saco, Sanford, Scarborough, South Berwick, Wells, Westbrook and York.

Unitil Energy Systems, Inc. is a New Hampshire corporation, the successor company from the 2002 combination of Unitil subsidiaries Concord Electric Company and Exeter & Hampton Electric Company. Concord Electric Company was organized in 1901 to provide electric service to customers in Concord, New Hampshire. Exeter & Hampton Electric Company was organized in 1908 to provide electric service to customers in Exeter, Hampton and surrounding communities in



New Hampshire. Today, our New Hampshire electric operations provides distribution service to more than 77,000 customers in the Capital and Seacoast regions of New Hampshire, serving the 31 communities of Allenstown, Atkinson, Boscawen, Bow, Brentwood, Canterbury, Chichester, Concord, Danville, Derry, Dunbarton, East Kingston, Epsom, Exeter, Greenland, Hampstead, Hampton, Hampton Falls, Hopkinton, Kensington, Kingston, Loudon, Newton, North Hampton, Pembroke, Plaistow, Salisbury, Seabrook, South Hampton, Stratham, and Webster.

Unitil Resources, Inc. was incorporated in New Hampshire in 1993 as a non-utility subsidiary of Unitil. Its affiliate, Usource, LLC, provides energy brokerage service to large energy users in more than 20 states throughout the United States seeking competitive electricity or natural gas supplies.

Unitil Service Corp. was incorporated in 1984 in New Hampshire to provide centralized administrative and management services to Unitil System subsidiaries. The office is located at Unitil's corporate headquarters facility in Hampton, New Hampshire, and operates a customer service center in Concord, New Hampshire.

1993: Unitil founds Unitil Resources, Inc.

2000: Usource, LLC is formed to provide energy brokerage services to large users

2002: Concord Electric Company and Exeter & Hampton Electric Company merge as Unitil Energy Systems, Inc.

2008: Northern Utilities, Inc. and Granite State Gas Transmission, Inc. are acquired by Unitil.



Financials:

Unitil (UTL) is a publically traded company on the New York Stock Exchange. Unitil posted total operating revenues of \$383.4 million in 2016, or earnings of \$1.94 per share. Our Senior Leadership Team members are profiled below:

Bob Schoenberger is Unitil's chairman of the board, chief executive officer and president. Prior to joining Unitil in 1997, Bob was president and chief operating officer of the New York Power Authority. Bob currently also serves as a trustee of Exeter Health Resources in Exeter, New Hampshire, and also on the Executive Committee. Bob is also a director of the Edison Electric Institute. Bob is a graduate of the University of Delaware and LaSalle University.

Mark Collin is Unitil's senior vice president and chief financial officer, a position he has held since 2003, and has also been the company's treasurer since 1998. Mark joined Unitil in 1988 and was Unitil's vice president of finance from 1995 until 2003. Prior to joining Unitil, Mark worked for the New Hampshire Public Utilities Commission as a utility analyst. Mark is an alumnus of the State University of New York at Cortland and the University of New Hampshire Whittemore School of Business and Economics. Mark is actively involved as a member of the Board of Directors of New Hampshire Public Television and currently serves on the Executive Committee and the Finance Committee.



Tom Meissner is Unitil's senior vice president and chief operating officer, a position he has held since 2005. Tom joined Unitil in 1994 and served as director of engineering from 1998 through 2003 and senior vice president, operations, from 2003 through 2005. Prior to joining Unitil he held a number of engineering and operations positions at Public Service of New Hampshire (now known as Eversource Energy). Tom graduated from Northeastern University with degrees in Electrical Engineering and Mechanical Engineering, earned his MBA from the University of New Hampshire, and completed the Tuck Executive Program at Dartmouth College's Graduate School of Business. He is also a registered Professional Engineer serves as a director of the Northeast Gas Association.

Todd Black is Unitil's senior vice president, external affairs and customer relations, a position he has held since 2009. Subsequent to this position, Todd served as President of Usource, a Unitil affiliate company, from 2003-2009.
