

## Typical Rate Change Dates:

Distribution Charge..... May 1, November 1  
Cost of Gas..... May 1, November 1  
Local Distribution Adjustment ..... November 1

## Terms of Payment:

The charges for gas service are net, billed monthly and are due and payable upon receipt. A late payment charge of 1% per month (12% per annum) will be assessed from the date of the bill on balances not paid within thirty days. When bills are paid by remittance through the mail, the postmark on the envelope shall be the date of payment.

## Definitions:

**Customer Charge:** The costs of providing services such as metering, billing and account maintenance. These are fixed costs and are not affected by the amount of natural gas you use.

**Distribution Charge:** The cost of delivering natural gas through our pipes to your home or business. It includes our investment in, and maintenance of, the pipe and other equipment that makes gas delivery possible.

**Local Delivery Adjustment:** The costs of environmental, energy efficiency, low-income assistance, and other programs.

**Cost of Gas:** The cost of the natural gas we supply to you, if you have not chosen another supplier. This charge includes the cost we pay for the gas, the cost of interstate transportation, and our cost of storing the gas.

**Supplier Charge:** The charge to transportation customers for gas you purchased from another supplier.
