

## To Our Customers:

The following summary provides the information you need to calculate your electric bill. Residential customers may be eligible to receive discounts under the New Hampshire Electric Assistance Program.

You will see a breakdown of the different components of your bill, including what part is electricity delivery and what part is electricity supply. The charges are essentially a more detailed breakdown of the costs you were already paying in your Unitil rates. It is important to note that Unitil makes no profit on your electricity supply.

Unitil customers have the ability to choose a competitive electric energy supplier. Unitil will continue to provide you with electricity through the Energy Service option, to ensure that your lights stay on. You may choose a Competitive Supplier at any time.

## Delivery Services:

**Customer Charge:** A monthly fixed charge that recovers the costs of metering, meter reading and preparing and mailing your bill. The Customer Charge does not change when your electric use increases or decreases.

**Delivery Charge:** Covers the costs of delivering electricity to you, including transmission costs and costs of providing and maintaining an electric system (poles, wires, transformers and substations) which is capable of serving your needs.

**Stranded Cost Charge:** Covers the costs associated with purchased power contract obligations that existed prior to restructuring.

### Taxes & Surcharges:

**System Benefits Charge:** Covers the costs associated with the statewide low-income electric assistance program and energy efficiency programs provided by the Company.

### Supplier Services:

**Energy Service Charge:** Covers the cost of power supplied to you by Unitil. This service is available to all customers who are not receiving energy supply service from a Competitive Supplier.

### Terms of Payment:

The charges for service under these rates are net, billed monthly and due 25 days following the date postmarked on the bill. For classification D, amounts not paid prior to the due date shall be subject to a late payment charge of one percent (1%) per month on the unpaid balance. For customers who qualify for certain low-income assistance programs, this fee will be waived. For classification G, amounts not paid prior to the due date shall be subject to a late payment charge of one and one-half percent (1.5%) per month on the unpaid balance.
